MACROS Examples

HX Review Statement:

- Health History does not negatively affect the driver's ability to operate a CMV.
- Driver is compliant with current Treatment
- Driver is not compliant with treatment with medications and medical card is pending until further information is obtained from his primary care physician.
- NOT COMPLIANT with current treatment
- HTN: The driver has been using BP medication since
- TBI: Significant event(s)
- MEDICAL HISTORY REVIEWED. Examinee denies any other significant medical history or current use of medication.
- Patient denied any medically limiting condition(s) or medication use.
- History disqualifies the driver
- Patient's previous DOT medical examination was issued for <2 years.
- Patient's previous DOT medical examination was denied.
- CANCER history
- Substance abuse treatment
- DIABETES: The driver reports he/she is actively under care by a medical provider to manage the diabetes mellitus. And the driver has been using diabetes medication to control their blood sugar since
- DIABETES: not compliant with treatment
- OSA: Was diagnosed with obstructive sleep apnea and provided an acceptable compliance report.
- OSA: Was diagnosed with obstructive sleep apnea and is not compliant with treatment.
- SURGERY: Patient stated full recovery and denied any functional impairment/disability or residual effects impacting their ability to safely operate a commercial motor vehicle.
- MEDICATION: Patient stated their condition is well-controlled on their medication and their medication is well-tolerated.

Other Testing:

- Neck circumference indicates high OSA risk (above 17 in.)
- Spirometry test result: PASS
- Spirometry test result: FAIL
- A1C score: CONTROLLED
- A1C score: UNCONTROLLED
- Failed UA warrants further testing

Exam Review Statement:

- The driver is safe to operate a CMV.
- Physical exam of this driver indicates regular monitoring. Driver is good to drive with monitoring.
- unremarkable exam
- ...rest of exam unremarkable
- The driver is UNSAFE to operate a CMV
- SPE test is warranted
